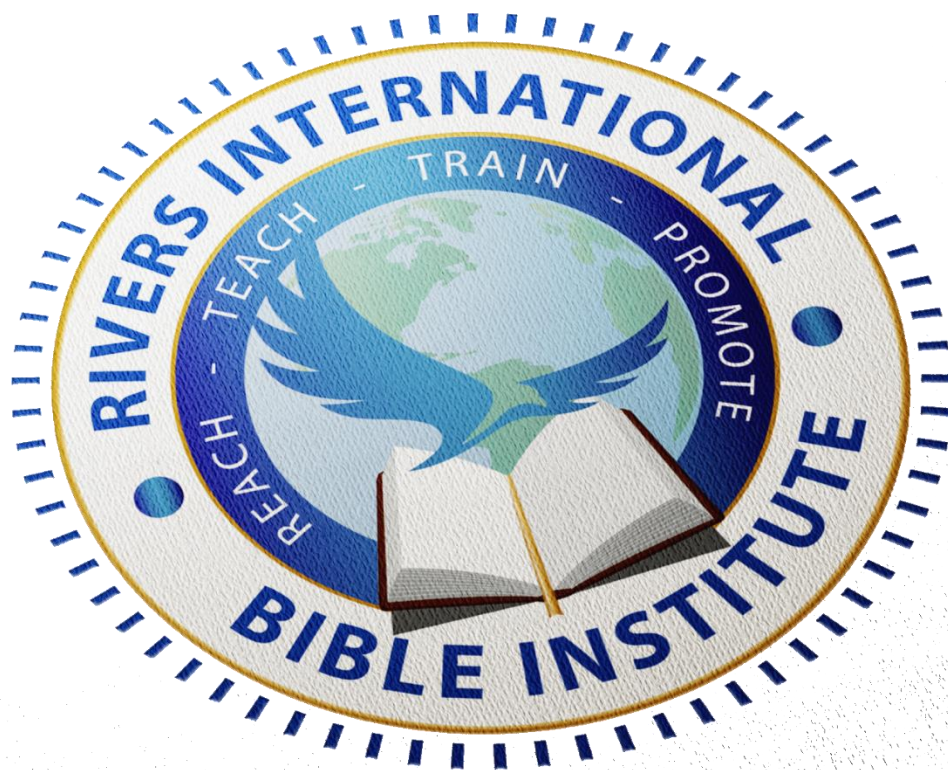

## REFUND POLICY

---

Application and registration fees are non-refundable. Course units can be returned to Rivers International Church c/o RIBI, P.O. Box 85, Parkton, NC 28371.

The amount of refund that students can receive if they withdraw from a paid class will be as follows:

- **during 1<sup>st</sup> week of classes – 60 percent refunded**
- **during 2<sup>nd</sup> week of classes – 40 percent refunded**
- **during 3<sup>rd</sup> week of classes – 10 percent refunded**

**Note: there will be no refunds after 3<sup>rd</sup> week of classes.**



# PAYMENT POLICY

---

We recognize the cost of education can be challenging for some students, and we have attempted to adjust our cost to help the students achieve their biblical goals to study the Word of God. Monthly payment arrangements can be setup with our office so that you can manage your budget while pursuing your degree program. A payment agreement with an initial deposit must be paid at time payment agreement has been signed and placed on file with the school.
